

Through the Homecare Choice Program, you can hire and pay caregivers to help you with personal care, pet care, companionship, household tasks, transportation, and relief care.

The Homecare Choice Program is an excellent in-home services option for individuals of any age needing help with personal care or household tasks, who want to hire a caregiver of their choice without having to worry about figuring out all of the legal requirements of being a household employer. We can assist you by paying your caregiver on your behalf, withholding and reporting payroll taxes, providing workers' compensation coverage, and ensuring your caregiver has passed a thorough background check.



How it Works

To get started, you;

- Complete a self-assessment and service plan on the Homecare Choice Registry to decide which services you want your caregiver to help with, such as making meals, going grocery shopping, assisting with bathing, and more.
- Decide which caregiver you would like to interview and hire from the Registry.
- Complete the enrollment paperwork for PCG Public Partnerships, LLC (PPL) with the help of your Homecare Choice Specialist.

- **Participants pay their caregiver using their own money, but PPL is here to help manage their funds.**

The Homecare Choice Program is responsible for:

- Helping to make sure caregivers are qualified to provide services. All caregivers on the Registry have passed background checks to help ensure participants' safety.
- Maintaining a registry that matches you to caregivers that best meet your needs based on what's important to you.
- Training you and your caregivers on how the Homecare Choice Program works.

With the money you give to the Homecare Choice Program for services, PPL will pay your caregivers on your behalf. PPL is also responsible for:

- Processing timesheets, so your caregivers can be paid for the services they provide.
- Withholding the necessary taxes and giving your caregivers their year-end W2 forms so they can file their personal taxes.
- Assisting you with obtaining an Employee Identification Number, so you can employ your caregiver.

PPL helps make home care services easy for you and your caregivers with the PPL BetterOnline™ web portal, which allows caregivers to submit their hours using an electronic timesheet, or eTimesheet. This helps make sure your caregivers are paid accurately and on time. Using BetterOnline, you are able to view budget reports to better control your funds and future.
